Min 5022 Matters Arising

1. Planning -all Planning issues relating to the application have been answered; a decision has been made to remove the skate park for the time being from the application. Application now consists of Zip Wire and the MUGA.
2. No more complaints received with regards to the barking dogs.
3. LED lights – if anyone has an issue then they should take the light post number and report it to the lighting department in Carmarthen and apply for a guard to be placed on the lamp post.
4. Tree survey reports have been requested.
5. Trees that have been inherited under the asset transfer come under county who will confirm what action to take after their arboriculture officer's report.
6. Knotweed – spraying took place last week, though it rained prior to and after the spraying, how effective it will be is questionable.
