2. Clerk announced that a fund had been secured from the Welsh Church Fund with reference to an application for Grant Support.
3. Clerk presented the Council with the Asbestos report on the Welfare Hall carried out by Enquin Environmental Limited.
4. Trimsaran Rugby Club have approached the Community Council to ascertain if the Council would be purchasing the changing rooms ,after some discussion it was advised that the Rugby Club make an application under the proposed Asset transfer scheme with the County Council .
5. Residences at Garden Suburbs complaining that young children with their parents are on motor bikes at the grounds at the rear of the property on a Sunday causing a nuisance.
6. Request made to obtain scheduled footpath maintenance for Trimsaran.
7. Request for Argoed field to be cut. Clerk advised that the cutting of this area no longer under County Council jurisdiction and that a private firm would be required to carry out the work.
