Min 5165 Minutes Arising

1. County Councillor Kim Broom spoke to Mr French before he left his post about the possibility of placing mats under the zip wire run to address the mud issue but Mr French was against placing matting due to the possibility of the users obtaining skin burns and advised on the use of astro-turf
2. Repair on the play equipment and bark quotation have been received.
3. Dr Surgery petitions forms will be handed in next week.
4. Volunteers from Bobol Bach will be doing some planting of the wild flower seeds.

Min 5167 County Councillors Report

1. Received an email from a Mr A. Francis regarding issues around grass cutting standards at various locations within Trimsaran and at Pen y Mynydd and dangerous boundary walls at Stradey Castle the Clerk has responded to the email.
2. Received confirmation that a decision had been taken to locate an electrical charging unit at the leisure centre car park.
3. Flooding at the lower end of the village, NRW have been in contact with the residences and businesses regarding the issue.
4. Additional bins request has been received and County have agreed to place bins at Argoed bus stop, Waun y Clun and the Picnic area on Mountain Road.

5. Glass problems being created with older children within the village and there have been trees that have been newly planted being uprooted and broken, individuals have been identified doing this and the Police have been informed. The councillors have all agreed that they wish the matter to be taken further by them.
6. There will be a new bus shelter located at Garden Suburbs which will display the arrival time of the next bus.
7. Bobol Bach has made an application under the Community fund scheme for a donation toward the purchase of an external storage unit, after some discussion the application for funding was granted.
8. Public Lighting have received a request from a resident near Ty Coch footpath requesting that the part night cell be removed from the lantern and for the light to remain on all night. After some deliberation the council agreed to the request, the clerk to inform Public Lighting of the decision.
9. Hall updates - there are some snagging works left but majority of the building work has now been completed. This week the cafe will be open Wednesday and Thursday for take away.
10. Fire and littering at Waun y Clun farm – Police, NRW and Environmental officers have attended and the occupier has been served notice to clean the rubbish off the land, further prosecutions matters will be taken forward by the agencies.
