Min 5116 Financial Report

Min 5117 County Councillors Report

1. Min 5104 – the wire on the zip wire has been installed an inspection will take place tomorrow.
2. To planters will be located around Plas y Sarn leisure centre, Wild flower turf planted by skate park area Mr Martin Taffetsauffer has agreed to loan a worker and a machine to remove the top soil on the 13 November. An amount of trees will be planted in the wet area near the football field
3. Oak planters to be located in front of leisure centre and recycling bins to be relocated
4. Fly tipping is still a major problem at Pontnewydd and Baglan Woods
5. Sally Bonnell has submitted a Heritage application grant.
6. Bt Kiosk adoption application submitted to Carmarthenshire County Council by clerk
7. Pobol Bach and Trimsaran junior rugby will be submitting invoices for the balance on the community fund
8. Chip shop owners have agreed to sponsor two hanging baskets
9. Leisure centre showed some improvement last week in trading.
10. Economic resilience fund application provided by County Council unable to apply as we are ineligible due to R.V being over the threshold
11. There is a possibility of access for a hardship fund through One Voice Wales.
12. Planning enforcement officers hhen ave been contacted regarding the sale of vehicles from the property on the entrance of Trimsaran from Llanelli
13. Been asked if Trimsaran could become a “No cold calling area” due to recent incidents – if it did then it would become an offence according to the trading standards web site to carry out such activates.

14. Substantial planning restrictions have been imposed on the property in Cae Linda overlooking the rear of a property fronting Heol Llanelli
15. Martin Taffetsauffer agreed to donate two hundred and fifty pounds towards Christmas trees
