Regarding planning application PI/08543 for six bungalows on land adjacent to Heol Llanelli. Construction of 6no. Detached Bungalows, and formation of Estate Road (Revision to that granted Planning Permission under S/05582) and Associated Infrastructure (Resubmission of PL/06116 refused 24/11/2023) Gwelfor, Heol Llanelli, Trimsaran, Kidwelly, SA17 4AG

Brynmelyn, 21 Heol Ddu, Pen Y Mynydd, Llanelli, SA15 4RN

Alleged Breach of Planning Control:

Erection of a concrete blockwork wall higher than 1.0 Metre above ground adjacent to the highway and higher than 2.0 Metres within the curtilage of the dwelling

Catherine Lloyd-Jenkins informed the meeting how the method of reporting planning applications on the Carmarthenshire County Council was displayed on their web site, it was agreed by all that this method could be presented in the same manner by the Clerk.

Chair Naomi Wilmot read a letter from Pembrey and Burry Port food bank requesting support from the Council,

It was proposed by Mari Arthur and seconded by Ioan Jones to donate fifty pounds. The proposal was agreed.

Min 5731

Charles and Co letter and the Risk and Investment Strategy to be deferred to the next meeting

Min 5732

A discussion to Federate the Trimsaran and Furnace schools with one governing body was discussed., this will be a hard federation as it has been a soft federation for the past five years.

Min 5733

County Councillor Kim Broom reported that a quotation had been received for the hanging Christmas tree decorations for the village for £1456, Bethan Walters proposed that in addition to the hanging decoration an amount of £1000.00 should be ring fenced for the Christmas tree lights, this was seconded by Alma Davies.

It was agreed by council to the £2456 spend for the Christmas decoration.

Min 5734

County Council requested that consideration be given to use the Local Government Public Works Loan facility to borrow to have contingency funding in place for unforeseen expenditure to complete the full renovation of the Old Miners Hall. Grant funders require evidence of funds available to match the 294k grant awarded towards the renovation. County Councillor Kim Broom requested that a sum amounting to 45k be sought with an interest amount of 3k.

After some discussion all council members agreed to the proposal and authorised the Clerk to make the loan application.

- 1.Mari Arthur requested that the Council have a photograph for the web site all councillors agreed to the request and a photograph was taken
- 2. Mari Arthur requested a lease of 7years for the rear part of the Miners Hall as a matter of urgency, the council agreed with the request and for County Councillor Kim Broom to proceed to formalise the agreement.
- 3. Mari Arthur requested an update on the footpath on Mountain Road; it was passed that the Clerk follow up on the request.
